INTRODUCTION

This document contains information related to additional charges as well as station-specific details. It is complementary to our Supplementary Terms and Conditions (the "Supplementary Terms") and our Master Air Waybill Conditions of Carriage (AWB prefix 369 or 233).

In the event of any discrepancies between this document, the Supplementary Terms, and the Conditions of Carriage, the Conditions of Carriage will take precedence and serve as the governing terms.

By placing a booking or using our services through any channel, you (the "Customer") acknowledge and agree to these terms. If acting on behalf of the shipper and/or end-customer, the Customer must ensure that both the shipper and/or end-customer accept and comply with these terms.

MSC Air Cargo reserves the right to benchmark its charges against those of competitors and may introduce new charges or modify existing ones accordingly. Customers will not be notified of any changes to applicable charges or fees and should ensure that they always refer to the latest version of this document on our website before making any new bookings.

INCURRED CHARGES

MSC Air Cargo reserves the right to invoice the Customer for all charges incurred due to reasons not attributable to MSC Air Cargo or our designated agents, even if such charges are not explicitly listed in this "Other Charges" document.

Additionally, the Customer agrees to indemnify MSC Air Cargo for any liabilities, costs, penalties, expenses, damages, or losses incurred because of the Customer's failure to comply with applicable laws and regulations. This includes, but is not limited to, illegal descriptions on packaging or negligent acts by the shipper.

BANK FEES AND LATE PAYMENT PENALTIES

All bank fees associated with the processing of payments must be borne by the customer. This includes, but is not limited to, wire transfer fees, currency exchange fees, and any additional charges incurred due to the method of payment chosen by the customer. The company will not assume responsibility for any bank-related fees or deductions that result in incomplete payment of the invoiced amount.

A late payment fee of 2% per month will be applied to any invoice that remains unpaid after 30 days from the due date. This fee will be calculated monthly, starting from the first day after the payment grace period ends. The customer will be liable for this penalty until the full payment is made.

In addition to the monthly late payment fee, an annual interest rate of 5.3% will be applied to any unpaid invoice amount. The interest will be calculated on a pro-rata basis, considering the duration of the overdue period. This interest serves as a penalty and will be added to the outstanding balance for each invoice that remains unpaid beyond the due date.

DEFINITION OF TERMINOLOGY

AWB FEE

Definition: This fee applies to all Air Waybills (AWBs) for processing shipment-related information.

Definition: This fee applies to all MAWB originating the European Union and the United Kingdom.

ELECTRONIC CUSTOMS NOTIFICATIONS FEE

Definition: This fee applies to all MAWB/HAWB for processing shipment-related information.

Type: Flat charge per FHL/FWB

Definition: This fee applies whenever a Cargo Charge Adjustment (CCA) is required.

SCREENING FEES

Definition: This fee applies to all shipments not tendered in secured status, based on the Special Handling Code(s). These security screenings are undertaken in alignment with the requirements of the relevant aviation security program and can be conducted through various screening methods. The acceptance of cargo is dependent on the availability of suitable methods of screening for the cargo at the point of origin.
